## Discover

Environmental and Land Use Law is a broad practice area, encompassing natural resources and historic preservation, endangered species protection, pollution control, regulatory compliance, housing law, and land use planning. Lawyers working in this area can be found at many levels of state and local government as well as government agencies such as the U.S. Environmental Protection Agency, U.S. Department of Housing and Urban Development, and U.S. Department of the Interior. Many lawyers also work for law firms doing zoning work or as part of their environmental and natural resources practice areas. Industry abounds with opportunities for working in regulatory compliance roles as well. Regardless of what path you choose, you are certain to be working with a diverse group of professionals including land-use planners, city officials, regulators, business leaders, scientists and engineers.

Law students who are interested in concentrating their studies in environmental and land use law may now receive a certificate. Students may also explore environmental and land use law without enrolling in the certificate program, and this curriculum guide provides an introduction to the related offerings at the College of Law.

# Learn

Environmental and Land Use Law is an interdisciplinary practice area. This list of advanced courses highlights some of the more popular courses taken; however, there are many other related courses in health law, historic preservation law, and urban studies that may interest law students. Students are encouraged to talk to the faculty advisors to tailor a course of studies to their interest area.
