## Discover

Family law includes several types of practices and touches on a variety of legal areas. Many attorneys' practices focus on domestic relations law, consisting primarily of matters related to marriage, divorce and child custody. Some attorneys have a child-focused practice that involves, for example, working primarily on abuse and neglect cases and/or serving as guardians ad litem in child custody, abuse and neglect and other child-related cases, while others work for the state doing child support enforcement. Yet others may focus their practice on family-building (via adoption and/or assisted reproductive technologies) or international and transnational aspects of family law (e.g., intercountry adoption, abduction and return cases, and family immigration matters). In any of these areas, a lawyer likely will be involved in all manner of practice, including counseling, pretrial work, trials, mediation, negotiations, and transactional work. Students interested in doing any of these areas of work and in learning how the law affects families, individual lives and intimate relationships would want to explore pursuing a family law practice.
