### Tracey Barbaree (Mon: 2:45)

Tracey Barbaree represents employers in all aspects of employment and civil rights litigation, with a focus on Rule 23 class actions and defending collective action claims under the Fair Labor Standards Act. She has been recognized as a Georgia "Super Lawyer" in Labor and Employment since 2008 and is listed in Chambers USA, America's Leading Lawyers for Business.

At The Ohio State University College of Law, Barbaree was a managing editor of *The Ohio State Law Review* and a member of the Order of the Coif. She also clerked for Judge Richard C.
